\$1,500,000	Near-drowning of 17 year-old girl; brain damage; pool safety.
\$1,200,000	Death of 50 year-old postal employee in rollover motor vehicle collision.
\$2,500,000	Amputation of both legs of disabled 45 year-old man caused by scalding bath water at hotel.
\$500,000	Hospital negligence in monitoring 8 year-old girl; brain damage.
\$1,200,000	Death of 60 year-old wheel-chair bound-man during a transport; failure to secure wheel chair.
\$900,000	Death of 42 year-old man in ER; failure to diagnose and treat cardiac condition.
\$450,000	Birth injury death due to failure to do a C-section and negligent resuscitation.
\$1,200,000	Death of 5 year-old boy from child abuse by foster-father who beat him; negligence of DSHS, school, hospital and ER doctor.
\$1,600,000	Death of 44 year-old woman from undiagnosed stroke in ER.
\$1,500,000	Death of 55 year-old man due to negligence by anesthesiologist during a gallbladder surgery.
\$500,000	Cardiac damage to 30 year-old woman, due to ER and hospital negligence.
\$2,500,000	Death of 30 year-old woman doctor due to undiagnosed and untreated cervical cancer; negligent cervical pap smear and laboratory analysis.
\$1,600,000	Death of 3 year-old child from asphyxiation due to inability of ER staff to remove toy balloon from her nasal passage and trachea; ER staff unable to perform tracheostomy or cricothyrotomy.
\$3,000,000	Birth injury; brain damage; failure to do a prompt C-section.
\$1,300,000	Death/murder of 58 year-old woman stabbed by a mentally ill man on conditional release from mental hospital and jail.
\$2,300,000	Death of 10 year-old girl in home fire due to product defect
\$8,000,000	Birth injury; brain damage; failure to do a prompt C-section.
\$350,000	Death of 22 year-old woman who drowned in a city-owned pool while taking swimming lessons; negligent pool safety.
\$1,200,000	Death from asphyxiation of 30 year-old hospitalized woman with Guillain-Barre syndrome; hospital and nursing negligence; failure to monitor feeding tube and ventilator.

\$3,200,000	Birth injury; brain damage; cerebral palsy; failure to do a prompt C-section.
\$100,000	Policy limits settlement for man suffering closed head injury due to jet-ski personal watercraft collision.
\$1,400,000	Hysterectomy to 22 year-old woman due to undiagnosed cervical cancer and negligent laboratory analysis.
\$400,000	Overdose of drug to infant by hospital staff causing brain damage.
\$500,000	Overdose of cancer-treating drug to a man with brain cancer causing seizures.
\$175,000	Tibial plateau fracture of woman hit by taxi while she was crossing street in cross walk.
\$750,000	Physical injury and brain damage to bicyclist cause by negligent automobile driver.
\$2,500,000	Diet drug caused heart and lung damage.
\$1,500,000	Death of 38 year-old woman due to undiagnosed stroke; ER and hospital negligence.
\$1,400,000	Birth Injury; brain damage; failure to do a prompt C-section.
\$400,000	Death of a 30-year old man due to sudden cardiac-arrest.
1,075,000	Death of 60 year-old man after diverticulitis (inflammation and infection of out-pouchings in the colon) (diverticula)); was unrecognized by abdominal pain in hospital.
\$2,500,000	Birth injury; brain damage; cerebral palsy.
\$450,000	Death of 54 year-old woman caused by peritonitis due to negligent puncture of her intestine during hysterectomy.
\$945,000	Defectively manufactured and tested drug which caused neurological damage to a 28 year-old woman.
\$250,000	Deep vein thrombosis (DVTs) after lower limb surgery; negligence of surgeon.
\$1,800,000	Death of 38 year-old man in motor vehicle collision due to trucker's negligence; and hospital negligence.
\$500,000	Negligent hernia repair causing multiple follow-up surgeries
\$350,000	Failure to diagnose and treat ovarian cancer; gynecology and radiology negligence.
\$1,250,000	Death of 62 year-old woman; failure to diagnose and treat oral cancer; negligence of oral surgeon.
\$750,000	Severe sepsis to 28 year-old man with untreated throat infection.
\$950,000	Death from failure to diagnose and treat cardiac symptoms in ER.

\$1,250,000	Major burn to 40% of body caused by fire from wood stove that overheated wall; defective wall covering product.
\$2,000,000	Severe injury and loss of use of arm to 15 year-old boy during wrestling practice when his arm went through a window. School sports injury.
\$1,800,000	Death of 32 year-old woman; failure to diagnose spinal cryptococcal meningitis.
\$1,000,000	Neglect, abuse, and failure to protect against bed sores to 24 year-old bedridden and mentally disabled man.
\$46,500,000	Quadriplegia to 30 year-old man who was shot at a Denny's restaurant; negligent security.
\$2,200,000	Birth injury; death; failure to do a prompt C-section.
\$2,000,000	Pulmonary hyperplasia and lung transplant due to defective drug Phen-Fen.
\$400,000	Death of 70 year-old man in auto accident.
\$2,350,000	16 year-old boy shot by landowner; quadriplegia.
\$2,500,000	Death of 60 year-old man due to failure to diagnose and treat kidney cancer.
\$8,500,000	Brain damage, quadriplegia and permanent vegetative state to 28 year-old woman; drug addicted anesthesiologist prematurely extubated patient.
\$1,000,000	Death of 41 year-old woman while driving her automobile; collision with a detached (wheel-off) truck wheel.
\$4,500,000	Burns to face, hands and chest to 60 year-old man when electrical box was not properly shut down resulting in surgeries and disfigurement.
\$1,800,000	Severe injury to leg during mudslide resulting in 12 surgeries to save his leg; permanent disability.
\$400,000	Burns and disfigurement to hands of 24 year-old man cause by downed live electrical transmission wire.
\$20,500,000	Judgment against manufacturer of drug causing hemorrhagic stroke in 42 year-old business woman.
\$500,000	24 year-old man with burned and disfigured fingers and hands from a fallen live electrical transmission wire.
\$300,000	Paraplegia to 64 year-old woman from medical malpractice of orthopedic surgeon; (insurance policy limit).
\$500,000	Death of 24 year-old woman from defective and unsafe automobile.
\$750,000	Multiple deaths of children due to un-odorized propane which exploded in home.
\$1,570,000	For economic loss from fraudulent sale of cattle herds; securities fraud.
\$900,000	Negligent hernia repair requiring multiple additional surgeries.
\$500,000	Failure to diagnose and treat ovarian cancer.

\$900,000	Arm of 9 year-old girl caught and mangled in outboard boat motor.
\$530,000	Failure to diagnose and treat impending heart attack in 48 year-old woman.
\$500,000	Misdiagnosed pap smear and negligent laboratory report.
\$5,500,000	Death of 63 year-old man from hepatitis A contracted from salad at restaurant.
\$1,800,000	Failure to diagnose and stabilize a thoracic fracture after auto accident; quadriplegia to 58 year-old man; negligent hospital care and ER doctor.
\$3,000,000	Birth injury; cerebral palsy due to HIE and failure to perform a prompt C-section.
\$5,000,000	Birth injury; cerebral palsy due to HIE; failure to monitor the electronic fetal heart strips and do a prompt C-section.
\$620,000	Cervical cancer due to misdiagnosed pap smear and negligent laboratory report.
\$780,000	Cervical cancer and death from misdiagnosed pap smear and negligent laboratory report.
\$425,000	Cervical cancer from misdiagnosed pap smear and negligent laboratory report.
\$2,000,000	Death of 36 year-old woman from undiagnosed and untreated stroke in hospital ER.
\$1,000,000	Failure to diagnose and treat breast cancer in 44 year-old woman.
\$500,000	Severe injury to face of 35 year-old woman trucker due to improperly secured plywood.
\$770,000	Breach of contract under Argentine law; under Napoleonic Law of Abuso de Derecho.
